ITEM 7. MATTERS ARISING/RESULTS OF RECOMMENDATIONS

- a. The Council is invited to note that at its meeting on 6 October 2015, the General Committee approved the following changes to the regulations, with effect from 1 January 2016:
 - (i) Regulation H(1)9.e Appointment of an additional judge in Championship classes
 - (ii) Regulation K3.c. Agility Warrants
- b. Recognition of Agility as a sport
The Council is invited to receive a verbal report regarding progress on this issue.

- c. Proposed Amendment of Regulation H 28.a.(9) (Disqualification and Forfeit of Awards)
The Sub-Committee noted the Council's deep disappointment with its decision not to recommend for approval the proposed amendment, which would allow a judge to judge dogs handled by his or her spouse, immediate family or resident at the same address as the scheduled judge, other than in Championship Classes and Kennel Club sponsored events. The Sub-Committee wished to record its dissatisfaction that the matter had been referred back to it for further consideration. It did not accept the Council's view that agility judging was not subjective in its nature and it did not consider it appropriate that the Council should request the Show Executive Sub-Committee and the Field Trials Sub-Committee to review the relevant 'F' and 'J' Regulations respectively as these areas were not within its remit. The Sub-Committee strongly reiterated its original decision not to recommend the proposed amendment for approval.
- d. Structure of the Council
The Council had requested the Sub-Committee to consider reducing the three-year embargo on Regulation changes to two and a half years, on the basis that a three-year embargo would not enable it to bring to fruition any proposals made as a result of its consideration of strategic issues, within a single term of office. The Sub-Committee accepted the Council's views, and clarified that its intention was to allow it to make recommendations within a single term of office.
- e. Grade changes
The Council is invited to consider the formation of a Grading Panel consisting of a sub-group of Council members to carry out a review of the grading structure.
- f. Breakaway Tyre
Following its discussion regarding the breakaway tyre at its meeting on 22 January 2015, the Council is requested to note that the Equipment Panel has seen and approved the breakaway tyre manufactured by Jaycee Jumps, and that the Activities Sub-Committee had approved its use. Designs by other manufacturers would be subject to the approval of the Equipment Panel. A Press Release has been issued.

- b. Dog Agility Incident Forms
At its meeting on 2 September 2015, the Activities Health and Welfare Sub-Group had discussed the use of Dog Agility Incident Forms (as used at the International Agility Festival) at other shows in order to enable a fuller picture of equipment-related incidents at agility shows to be understood. It was agreed that the suggestion for use of the forms at shows had originated with the Agility Liaison Council and that therefore completed forms should be returned to show secretaries who could, if they wished, collate the information and forward it to the Kennel Club should they wish to draw a particular issue to its attention. It was agreed that the form was to be made available from the Kennel Club's website for use by show organisers. ITEM 12. DISCUSSION ITEMS

- a. Collapsible Tunnel - Mr I Mallabar Miss L Olden

Mr Mallabar requests that the Council revisit the issue of the Collapsible Tunnel. He is aware that this was considered at the last meeting of the Council on 13 July 2015. He also accepts the reasoning behind the decision reached at that meeting given the lack of available research or data.

There have been calls to change the tunnel including some to shorten the length of the chute but without any evidence that this would help or indeed if it would cause any further issues.

Mr Mallabar believes that recent research may give the Council more evidence with which to consider the specification of the tunnel. He asks that Council consider if modifying the specification would be beneficial to the comfort and safety of the agility dog.

b. Timing Failures – Mr M Bacon

Mr C Huckle

Mr Bacon wishes to raise concerns regarding dogs being stopped by the ring party in mid run due to timing failure, and requests that the Council discuss and clarify the procedure to be followed where a timing failure occurs.

At the judging seminar attended by Mr Bacon it was stated that it was not the correct procedure for the dog to be stopped in mid run by the ring party, for the following reasons:

- It may be dangerous, particularly if the dog is on the dog walk, seesaw, or in a tunnel.
- The scribe should be watching the judge not the timing.
- The judge is in charge of what happens in the ring not the ring party.
- Roughly 10% of dogs will get a clear round so for approximately 90% a timing failure is not relevant.

It was recommended at the seminar that in the event of a timing failure the judge should be informed after the run is completed, and that the judge should decide if there should be a re-run which would be from scratch. The ring party should be briefed by the judge regarding this issue.

c. Startline Rule – Mr M Bacon

Mr C Huckle

The Council is invited to consider the practice by some competitors of starting the dog by taking it past the first jump, setting it up and then sending it back around the jump, which appears to be becoming more common. Some judges accept this practice as there is no clear rule about it. Others fault it, or say in their briefings that they will fault it as a refusal, as the dog has passed the line of the jump. In some cases this has led to disagreement between competitors, judge and ring party.

The Council is requested to clarify the matter.

d. Control of scoring tickets – Mr M Bacon

Mr C Huckle

Mr Bacon notes that it has become common practice for score tickets to be handed to competitors when booking in with the collecting ring steward, and in some cases, a number of tickets (4-6) are collected from competitors whilst in the queue, and handed to the scribe. In other cases the ticket is handed to the scribe by the competitor shortly before his or her run, or is taken from the competitor by another member of the ring party and handed to the scribe.

Mr Bacon is concerned that these practices may give rise to considerable confusion and greatly increase the possibility of errors occurring, such as competitors running on the wrong ticket, particularly if weather conditions are poor. It also increases the opportunity for cheating or accusations of cheating. He wishes to suggest that score tickets should only be handled by the ring party and not by competitors.

The Council is requested to clarify the correct procedure.
